1. 银行工作日12:00前接收的存入实物股票指示, 将在当日处理, 12:00后和非银行工作日接收到的存入实物股票指示, 将于下一个工作日处理。 The Physical Scrip Deposit will be handled on that working day if it is submitted before 12:00, otherwise it will be handled in the following working day.
2. 实物股票将于确认签收后当日存入混沌天成国际证券期货有限公司客户账户, 只限沽出而不可提取结余。当实物股票以香港中央结算(代理人)有限公司名义成功登记后, 股份才会记存入投资者户口持有人的股份户口内, 并成为可动用的结余。登记程序通常需时 12 至 13 个工作日。The physical scrip will be deposited into the client's account of CIF Securities Futures Limited upon the receipt is confirmed and for sell only but not an available balance. Physical Scrip will only be credited to an Investor Participant's stock account and become available balance when the shares have been successfully registered in the name of HKSCC Nominees Limited. The registration process usually takes about 12 - 13 business days.
3. 投资者户口持有人可透过实时查询功能, 查询其存入股票后可供动用的户口结余。Investor Participants can enquire about their available balances after deposit via the Online Enquiry function for stock balance.
