- 1. 银行工作日12:00前接收的实物股票提取指示,将在当日处理,12:00后和非银行工作日接收到的实物股票提取指示,将于下一个工作日处理。 The Physical Scrip Withdrawal will be handled on that working day if it is submitted before 12:00, otherwise it will be handled in the following working day.
- 2. 香港中央结算(代理人)有限公司处理实物股票提取程序通常需时 12 至 13 个工作天。The process of Physical Scrip Withdrawa usually takes about 12 13 business days by HKSCC Nominees Limited.
- 3. 投资者户口持有人可透过实时查询功能,查询其存入股票后可供动用的户口结余。Investor Participants can enquire about their available balances after deposit via the Online Enquiry function for stock balance.
- 4. 每只实物股票提取证券每手HK\$5手续费,最低收费为HK\$30。The Withdrawal Fee is HK\$5/lot/securities, min HK\$30.
- 5. 从本公司通知客户可以领取实物股票日起计,如果客户在一个月内都没有领取股票,本公司会把股票重新存入客户的帐户并退回到中央结算系统保管。客户如需要再次领取,则需要重新支付手续费。If client do not collect the physical scrip within one month from we notify clients of the collection date, the physical scrip(s) will then be deposited back to client's account and maintained with CCASS. Clients have to pay handling charge for collecting the physical scrip again.
